driver's seat and/or safety belt that may not have been tightened to specifications.

Basis for recall population determination: Vehicle assembly records were reviewed to determine vehicles in which the attachment bolts for the driver's seat and safety belt may not have been tightened to specifications. The information was based upon records from production tooling and quality systems which recorded bolt tightening torques during the assembly process. The records indicated that potentially affected

VINs were produced from Oct 20, 2018 to Dec 15, 2018.

Chronology:

On January 16, 2019, during vehicle assembly, a rattling noise was noticed from the area near the attachment point of the driver's safety belt. Initial analysis suggested that the bolt used to secure the belt to the vehicle was inserted, but had not been tightened to specifications. All potentially affected vehicles were blocked at the plant.

Reviews of the bolt tightening data from production and quality systems, for all vehicles from Start of Production up to the vehicle block, were performed. During this review, it was also revealed that attachment bolts for the driver's seat may not have been tightened to specifications.

Production records were reviewed to determine the number and production range of potentially affected vehicles.

On February 6, 2019, BMW decided to conduct a voluntary safety recall.

BMW has not received any reports, nor is BMW otherwise aware, of any accidents or injuries related to this issue.

Description of Remedy:

Description of Remedy Program: Attachment bolts for the driver's seat and safety belt will be inspected and,

if necessary, tightened to specifications.

Owners will be notified by First Class mail and instructed to take their vehicle to an authorized BMW center to have the remedy performed for free. If this condition were to occur to a potentially affected vehicle prior to the recall, the remedy would be covered by the BMW New Vehicle Limited Warranty program. Therefore, reimbursement for a prenotification remedy re Part 573.13 and Part 577.11 is not necessary.
