Problem Description:

BMW of North America, LLC (BMW) is recalling certain 2021 430i and M440i 4 Series Convertible vehicles. In certain side-impact crashes, the head-thorax air bag may not deploy as intended.

Consequence:

An air bag that deploys incorrectly can increase the risk of injury in a crash.

Remedy:

The remedy is currently being developed. All affected vehicles are still in dealer inventory, and therefore no owner letters will be mailed. The recall is expected to begin in March 2021. Owners may contact BMW customer service at 1-800-525-7417.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
